The infrared spectrum emitted by the Kontur™ deep heat system is reputed an astounding range of possible therapeutic and weight loss benefits. As with any program, results may vary and Electric Sunshine LLC does not offer any guarantees. Even though infrared therapy is considered a non-invasive treatment, it is recommended that you consult a physician if you have any health questions or concerns.

Please read the following:

1. If you have a disease of illness, consult a physician.
2. If you are using any prescription drugs, check your physician or pharmacist for any possible change in the drugs effect due to interaction with infrared energy.
3. It is considered inadvisable to raise the core temperature in someone with adrenal suppression and systematic lupus erythematosus or multiple sclerosis, by some authorities.
4. If you are pregnant, or suspect you may be, discontinue your use.
5. Metal pins, rods, artificial joints, or any other surgical implants generally reflect infrared rays and thus not heated by this system; nevertheless you should consult you surgeon prior to using the Kontur™ system. Certainly, usage of the Kontur™ system must be discontinued if you experience pain near any such implants. Silicone does absorb infrared energy. The infrared rays may warm implanted silicone or silicone prostheses for noses or ear replacement. Since silicone melts at 200° C (392° F), it should not be adversely affected by the usage of the Kontur™ system. It is still advised that you check with your surgeon and possibly a representative from the product manufactured to be certain.
6. Heating of the low back area of women during their menstrual period may temporarily increase their menstrual flow. Once a woman is aware that this may occur, she can choose to allow herself to possibly experience this short term effect without worry or simply avoid the Kontur™ system usage at that time cycle.
7. Hemophiliacs and anyone predisposed to hemorrhage should avoid the Kontur™ system usage or any type of heating that would induce vasodilatation, which can potentate the tendency to bleed.
8. Obviously, should any condition worsen with the use of the Kontur™ treatment, the use of the system should be discontinued.
9. People do not experience pain using the Kontur™ system unless such is contraindicated. If you do, the use of radiant heat is clearly inappropriate for you at that time.
10. DO NOT attempt to self-treat any disease with this Kontur™ system without direct supervision of a physician.

THE KONTUR™ TREATMENT MUST NOT BE CARRIED OUT IN CASE OF: Over activity of the thyroid gland, cardiac infarction, cardiac weakness, constriction of the coronary blood vessels, marked high or low blood pressure, diabetes requiring insulin treatment, disturbances to the function of the kidneys and associated organs, fever, severe general infection, contact allergies, skin diseases, open wounds, newly acquired shingles, pregnancy, medicines taken at the same time in which cause increased sensitivity to physical stimulation (for example: antibiotics). In case of severe varicose veins, the doctors treating the condition should be consulted before treatment.
